Regulations Concerning Foreign Researchers at Tokyo University of Foreign Studies

Article 1 Purposes

These Regulations provide matters necessary for the term of employment agreement, salary, etc. of Foreign Researchers of Tokyo University of Foreign Studies (hereinafter referred to as the "University") under the provisions of Article 4, paragraph 3 of the Working Regulations for Employees of Tokyo University of Foreign Studies (Regulation No. 52 of 2004; hereinafter referred to as the "Working Regulations").

Article 2 Definition of a Foreign Researcher

The term "Foreign Researcher" means a person whom the University invites and who is employed as a researcher for the purpose of participating in joint research, etc. in order to promote academic research.

Article 3 Determination of candidates

- 1 Candidates for Foreign Researchers shall be determined by the President on the recommendation of deans.
- 2 In the selection process, due consideration shall be paid to the qualifications of candidates such as their educational research results, etc. in the same manner as teachers.

Article 4 Invitation procedure, etc.

An invitation letter shall be issued in the name of the President and shall provide details of the conditions for invitation such as affiliate organizations, research subject, working hours, invitation period, salary, travel expenses for taking a new post and returning home, etc. In this case, the period of invitation shall be specified as per the actual plan regardless of the fiscal year.

Article 5 Conclusion of agreement

- 1 The agreement for work shall be made between the President and the Foreign Researcher.
- 2 The agreement in the preceding paragraph shall be concluded in Japanese and English. However, if the foreign national can fully understand the agreement in Japanese, the agreement may be written only in Japanese.

Article 6 Term of employment agreement

The term of employment agreement shall not exceed one (1) year, and if the contract is made in the middle of a fiscal year, the end thereof shall be the last day of such fiscal year. However, this period may be renewed as necessary.

Article 7 Salary

- 1 Foreign Researchers shall be provided with the following salaries:
 - (1) Base salary; and
 - (2) Commuting allowance.
- 2 Base salary for Foreign Researchers shall be Categories A and B. Category A shall apply to those who have achieved outstanding research results, and Category B shall apply to other persons.
- 3 The monthly base salary shall be as shown in Appended Table 1.
- 4 The subcategory for those applicable for Category B shall be determined by the number of years of his/her experience after graduation from a university or junior college which is calculated in accordance with Appended Table 2 (Years of experience conversion table).
- 5 The provisions of Article 17 of the Salary Regulations for Employees of Tokyo University of Foreign Studies (Regulation No. 54 of 2004, hereinafter referred to as "Salary Regulations") shall apply mutatis mutandis in determining the commuting allowance.
- In addition to the provisions in the preceding paragraphs, the provisions of the Salary Regulations shall apply correspondingly to matters regarding the payment of salary.

Article 8 Duties, working hours, holidays, and leave

The provisions for teachers of the University shall apply mutatis mutandis to the duties, working hours, holidays and leave of Foreign Researchers.

Article 9 Travel expenses for transfer and return

When a Foreign Researcher transfers to Japan or returns home, the following travel expenses shall be paid to such Foreign Researcher. However, expenses for returning home shall be, in principle, provided in case of returning home promptly after the expiration date of the employment agreement period.

(1) Persons applicable for Category A and those under Category B-4.

Railway fare, ferry fare, air fare, car fare, daily allowance, hotel charge, table charge, and miscellaneous travel expenses incurred in the grade of duty corresponding to Grade 11 of the base salary schedule for clerical and technical services prescribed in Article 4, paragraph 2 of the Salary Regulations (hereinafter referred to as the "base salary schedule for clerical and technical services") required by the most economical and usual route and method of the trip.

(2) Those under Category B-2 or B-3

Railway fare, ferry fare, air fare, car fare, daily allowance, hotel charge, table charge, and miscellaneous travel expenses incurred in the grade of duty corresponding to Grade 9 of the base salary schedule for clerical and technical services required by the most economical and usual route and method of the trip.

(3) Those under Category B-1

Railway fare, ferry fare, air fare, car fare, daily allowance, hotel charge, table charge, and miscellaneous travel expenses incurred in the grade of duty corresponding to Grade 6 of the base salary schedule for clerical and technical services required by the most economical and usual route and method of the trip.

Article 10 Provision of title

In the event the Foreign Researcher is deemed to be eligible for the position corresponding to a professor or associate professor of the University or above, the President shall provide such researcher with the title of visiting professor or visiting associate professor.

Supplementary Provisions

- 1. The amendments to the Regulations Concerning Foreign Researchers at Tokyo University of Foreign Studies will take effect on April 1, 2025.
- 2. The monthly base salary of foreign researchers will continue to be subject to the same salary as previously specified in the Appended Table 1 prior to the day the amendments take effect.
